## **Tenure Track Faculty Position in Large Animal Internal Medicine**

The Department of Clinical Sciences in the College of Veterinary Medicine at Cornell University invites applications for a tenure track Large Animal Internal Medicine faculty position. This position will result in a total of four large animal internists with the goals of supporting robust pre-clinical and clinical research programs, providing excellent services in the Hospital, and maintaining a strong teaching and outreach program.

The Large Animal Internal Medicine service is supported by three internal medicine residents and experienced licensed veterinarian technicians, during regular and after-hours in a comprehensive, state-of-the art teaching and referral hospital. The Cornell University Hospital for Animals is equipped with extensive therapeutic and diagnostic equipment, including portable ultrasound, video-endoscopy, point-of-care testing, intensive care facilities, 1.5 tesla MRI, 16-slice CT, nuclear imaging, and easy access to Cornell Animal Health Diagnostic Center/New York State Veterinary Diagnostic Laboratory. In addition, the Cornell Equine Park, a 165-acre facility close to the College, offers teaching, research, breeding and foaling services; and the Cornell Ruffian Equine Specialists, located in Elmont, NY, serves a diverse clientele of Olympic athletes, world class race horses, national level performance horses, and everyday companions.

Candidates must have a DVM or equivalent degree. Board certification in large animal internal medicine (ACVIM or ECVIM) is required. Clinical and/or basic science research experience is desirable. Clinical expertise in equine neuromuscular diseases, cardiology or emergency and critical care are strongly desired.

Distribution of effort in the section and department will be determined in accordance with the service needs, academic priorities, and the candidate's expertise and academic goals in large animal internal medicine. The Section provides care for patients in the Cornell University Hospital for Animals, a primary and secondary care service and teaching facility with a diverse caseload, and an established referral base. Clinical service and teaching responsibilities are distributed among the faculty members and residents. Faculty have the opportunity to participate in training of residents and professional students, as well as undergraduate and graduate students. Faculty members are expected to develop and sustain a program in clinical, basic, and/or translational research. Independent research space is available. Cornell is a world-class research institution with extensive research facilities and opportunities on campus for collaboration with basic scientists of all disciplines. Extensive opportunities for collaborative research exist at the College and University, including Cornell Weill Medical College and Cornell Tech campuses in New York City.

Clinical duties require flexible working hours that may include daytime, evening, and weekend responsibilities. The candidate should have strong interpersonal skills and the ability to work cooperatively with all of the sections in the Hospital.

Salary, rank and title will be commensurate with academic credentials and experience.
